### PRESIDENT-ELECT ~ DR. MICHAEL HARTLEY



**Dr. Michael T. Hartley** is an associate professor and coordinator of the M.A. Degree Counseling Program specialization in Rehabilitation and Mental Health at The University of Arizona. As an ethics scholar in rehabilitation counseling, much of his scholarship on ethics has targeted distributive justice issues and therefore his scholarship on ethical obligations has focused on the importance of promoting resilience and of advocating against ableism or the preference for able-bodiedness. His research on the pattern and prevalence of ethical issues within rehabilitation counseling practice guided revisions to the recently revised 2017 Commission on Rehabilitation Counselor (CRCC) *Code of Professional Ethics for Rehabilitation Counselors*, a taskforce he served on. Additionally, his research has informed grant-funded projects to promote resilience among military veterans with spinal cord injuries and youth with disabilities during the school-to-work transition. He recently co-edited the second edition of *The Professional Practice of Rehabilitation Counseling*, a textbook detailing the evolution of rehabilitation counseling from its inception in federal legislation in the early 1900s to its current recognition as a specialization of the counseling profession. It currently is the only up-to-date introductory text for the 100 or so programs in rehabilitation counseling that prepare rehabilitation counselors to provide services across diverse employment settings, including mental and behavioral health, one of the fastest growing aspects of counseling and an expertise necessary for new graduates interested in seeking licensure. Dr. Hartley is knowledgeable about the profession and professional practice of rehabilitation counseling, and is deeply committed to defining and preparing rehabilitation counselors to work ethically and effectively with persons with disabilities.

### CHAIR OF ARCA'S COUNCIL ON RESEARCH & KNOWLEDGE

#### DR. MAUREEN MCGUIRE-KULETZ, CRC

**Maureen McGuire-Kuletz, Ed.D, CRC** is an Associate Professor in the Rehabilitation Counseling Program and Co-Director of the GW Center for Rehabilitation Counseling Research and Education. She has more than 20 years of experience working for state VR agencies (blind and general) as well as in private non-profit and private for-profit rehabilitation counseling agencies. She has presented at national, state and regional conferences and has actively served on the boards of the National Council of Rehabilitation Educators (NCRE), the National Rehabilitation Association (NRA), the US Department of Veterans Affairs Vocational Rehabilitation and Employment Advisory Committee and the Vocational Evaluation and Career Assessment Professional National Association. Her research interests include ethics, distance education, disability and poverty, and services to veterans with disabilities. She has secured more than \$8 in federal grant projects and edited, authored and co-authored numerous publications.



#### DR. MATTHEW SPRONG, CRC, LCPC, CADC, CLDP



**Dr. Matthew E. Sprong** is an Assistant Professor of Rehabilitation Counseling at Northern Illinois University. Dr. Sprong's professional experiences involves private and forensic rehabilitation consultation, e.g., Life-Care Planning, Worker's Compensation, Personal Injury Litigation, Impartial Vocational Expert Testimony in Social Security Hearings, substance abuse counseling, program evaluation, and vocational services, i.e., vocational evaluations, job placement services, in a community-based rehabilitation program. He has authored over 20 refereed journal articles, has several book chapter publications, and multiple presentations at the local, state, and national levels. He is currently the President of VEWAA and the Illinois Chapter of the International Association of Rehabilitation Professionals (IARP). Dr. Sprong is a certified rehabilitation counselor, licensed clinical professional counselor, certified alcohol and drug counselor, and certified life care planner.

**DR. PAIGE DUNLAP, LPC, CRC, NCC, ACS, PVE**

**Paige N. Dunlap, Ph.D. LPC, CRC, NCC, ACS, PVE** is an Assistant Professor at North Carolina A&T State University. Her research focuses on aspects of Rehabilitation Counselor Education including counselor supervision, transition-age youth with disabilities, and multicultural issues. Specifically, she has published a number of articles on the rehabilitation counseling implications of providing services to gang members and other criminal populations with disabilities. Dr. Dunlap is the owner of Dr. Paige Dunlap and Co., PLLC where she provides counseling, consultation, and vocational evaluation services. She currently serves as the American Rehabilitation Counseling Association's Governing Council Representative to the American Counseling Association. In the past she has also served on the CRCC Ethics Committee and has been awarded both the American Counseling Association – Counselor's for Social Justice Ohana Award and the Association on Multicultural Counseling and Development – Professional Development Awards.



**DR. DAVID PETERSON, CRC, LMHC, LPC**



**David B. Peterson, Ph.D.**, Professor at California State University, Los Angeles, is a Certified Rehabilitation Counselor, licensed mental health counselor (LMHC, inactive), and licensed clinical psychologist (California, Illinois) with expertise in applying psychological principles to clinical problem solving in disability and function. For nearly three decades he provided or supervised counseling and psychological services for people with a wide range of disabilities (chronic and severe psychiatric diagnoses, deafness, developmental disabilities, stroke, spinal cord injury, traumatic brain injury, and other disabilities) across the lifespan. Teaching focused on applying psychological principles to working with people with a broad range of disabilities, including 46 course preparations in 20 content areas within programs accredited by the Council on Rehabilitation Education (CORE), the Council for Accreditation of Counseling and Related Educational Programs (CACREP), and the American Psychological Association (APA). For the past decade served as Medical Expert for Social Security

Administration's Office of Disability Adjudication and Review for adult and child psychiatric disability cases. His scholarship focused on the International Classification of Functioning, Disability and Health (ICF), and ethical decision-making. He has contributed to 61 scholarly publications, 46 local and national presentations, directed six research and training grants totaling over \$1.7 million, and is a member of four editorial boards for peer-reviewed journals.

**RESEARCH AWARD**

Nominations are being sought for the (2017) American Rehabilitation Counseling Association (ARCA) **Research Award**, which recognizes and honors high quality, empirical research in the field of rehabilitation counseling. Research published in peer-reviewed outlets in 2017 will be considered. If the submission is accepted in the year of 2017 but not published yet, will be accepted. Reviewers for this annual award are instructed to evaluate the methodology, data collection, sample size, sample characteristics, data analysis, data interpretation, and statistical integrity of the work. A standard evaluation form is used and volunteers are asked to be evaluators.

Nominations must be emailed to Mary Huber, at [Mary.Huber@wright.edu](mailto:Mary.Huber@wright.edu) and must include a full APA reference of the publication, and an electronic copy, link, or pdf file of the complete research article/work.

**JAMES F. GARRETT AWARD**

Nominations are being sought for the 2017 American Rehabilitation Counseling Association (ARCA) **James F. Garrett Award for a Distinguished Career in Rehabilitation Research**, which recognizes excellence in research contributions over one's career. The nominee may or may not be retired in order to qualify. Nominee's published research should span at least 15 years and focus on rehabilitation counseling.

Nominations should include strong evidence supportive of the nomination, e.g., letters of support, samples of publications, and curriculum vitae.

## ACA GOVERNING COUNCIL REPRESENTATIVE REPORT

Greetings ARCA Community!

As the ARCA's representative to the ACA Governing Council, I want to ensure that I am keeping you abreast of the latest information and updates. The Governing Council has been busy over the last few months, convening both in Washington, D.C., on July 13-15, 2017 and in Chicago, IL, on October 2-4, 2017. As with most organizations, strategic planning is an essential function. As such, much of the two meetings were devoted to the continuation of solidifying a strategic plan that will lead us into the next few years. Here are some of the highlights from both meetings:

- ❖ President Lawson was featured on Good Morning America to speak about the tragic shooting in Las Vegas.
- ❖ Portability – There is a link on the ACA website under licensure which showcases the ACA portability model. Letters have been sent to states regarding the model. The organization will reach out to and follow up with how the states feel about the letter and model. - ❖ Human Rights Statements regarding subjects such as deportation and gender identity are being developed.
- ❖ Update on Health Care Reform and the impacts on Mental Health. ACA opposed the healthcare reform bill due to loss of coverage and increased costs.
- ❖ Brand and Engagement – The organization is trying to transform ACA from a traditional membership organization to a more communication-based company. This will mean increasing the customer experience.
- ❖ Plans for 2018-2020 – Including strategic objectives and results. International partnerships – including a representative on the United Nations NGO committee; partnerships with the Korean Counseling Association; partnerships with the Britain and Ireland regarding a joint conference.
- ❖ Partnerships with the Boys and Girls club are continuing. Working on developing a toolkit for trauma this year.
- ❖ ACA received 2017 APEX Awards for articles written in *Counseling Today*.
- ❖ The Executive Council will meet to discuss and report back to the Governing Council about strategies to increase participation in ACA leadership positions from private practice practitioners.
- ❖ The Executive Council will meet to discuss and report back to the Governing Council about how to advocate for Medicare provider status. This may be difficult given the current Congress makeup.
- ❖ ACA and ASCA are developing a new collaborative relationship since ASCA functions as an organization separate from ACA. Most members of ASCA are not members of ACA.
- ❖ A motion was passed to, when feasible, have a gender inclusive restroom facility at the ACA conference.
- ❖ There is ongoing discussion on the ACA conference selection process and how to best ensure that there is representation of all content areas.
- ❖ The Nominations and Elections committee, which I am part of, is working on new ways to innovate the "Meet the Candidates" session at ACA. For example, maybe more use of technology, possibly during a time when no CEUs are given, etc.
